GENERAL:

Manufacturer to meet or exceed specification & preamble guidelines. Any discrepancy to the specifications must receive written approval by G70. Furnishings made to contract quality. All fabrics, lining, and fill materials, to comply with state and local codes. G70 shall be provided shop drawings of finished items prior to final production. All pieces must conform to manufacturer's standard catalog specifications, or G70 custom detail drawing.

All dimensions are given in inches unless otherwise noted.

Disclosure: Vendors shall disclose all products and project failures within the last seven years. If rejected, must provide remedies, and submit solutions and or steps for client satisfaction or approval.

Responsibility for Purchasing Agent and/or Furniture Dealer:

The role of the Designer shall be limited to review of shop drawings for general conformance with design as outlined in drawings and FF&E specifications.

The responsibility of the Purchasing Agent (PA) shall include but not restricted to:

- a. Assurance that procured items meet or exceed the specifications.
 - a. Provide third party quality review at factory prior to finishing and prior to packing before shipment.
- b. Dimensions are in conformance with the specification.
- c. Confirmation of total quantities.
- d. Coordination of tracking schedule and scheduling delivery with General Contractor and Owner.
- e. Consolidation and Freight: PA is responsible for consolidation, freight forwarding, and delivery to site.
- f. Receipt: PA is responsible for receipt of goods at site on behalf of Owner.
- g. Coordination and oversight of installation by qualified furniture installers.
- h. PA is responsible for coordination of on-site cleaning post installation.
- i. Conducting punch list.
- j. PA is responsible for management and settlement of any damage or claims with installer and general contractor post installation.
- k. Filing of any freight or damage claims with vendors.



WOOD - General:

All Casework, Millwork and Furnishings shall comply with the following below.

Submit shop drawings showing all fabricated casework items in plan view, elevations and cross-sections to accurately indicate materials used, details of construction, dimensions, methods of fastening and erection, and installation methods proposed. Shop drawing casework items shall be clearly cross-referenced to casework items located on the project drawings. Shop drawings shall include a finish schedule of all casework items to include all countertop, exposed, and semi-exposed cabinet finishes, patterning, hardware, and fittings. Items to be factory finished, only final touch up, cleaning, and polishing, permitted after delivery and installation at the site.

- a. Architectural Woodwork Standards: Unless otherwise indicated, comply 2014 AWI, AWMAC, WI – "Architectural Woodwork Standards, 2nd Edition" for grades of interior architectural woodwork indicated for construction, finishes, installation, and other requirements. Provide Custom-grade complying with AWI Quality Standard Sections 100, 200, 400, 1500 and 1700 unless otherwise noted.
- b. Softwood Lumber Standards: Comply with U.S. Department of Commerce PS 20 and with applicable grading rules of the respective grading and inspection agency for the species and product indicated.
 - i. Provide kiln-dried lumber having a moisture content from time of manufacture until time of installation not greater than values required by the applicable grading rules of the respective grading and inspecting agency for the species and product indicated.
- c. Hardwood Lumber Standard: Comply with National Hardwood Lumber Association (NHLA) rules.
 - Moisture Content of Hardwood Lumber: Provide kiln-dried lumber having moisture content from time of manufacture until time of installation within a range of 8% to 13% for individual pieces, and an average of 11% for the entire lot.
- d. Plywood Standards: Comply with U.S. Department of Commerce PS 1 for softwood plywood; PS 51 for hardwood plywood.
- e. Fabricator Qualifications: Millwork and casework specified in this section shall be produced by a custom millwork shop that employs skilled workers and that is regularly engaged in the manufacturing of similar items and with a minimum 5-year history of successful production acceptable to the Architect.
- f. Regulatory Requirements: Comply with applicable provisions Department of Justice's 2010 ADA Standards for Accessible Design for casework.



- g. Fabricate casework to dimensions, profiles, and details indicated. Ease edges to radius indicated for the following: Corners of Cabinets and Edges of Solid-Wood (Lumber) Members and Rails: 1/16 inch.
- h. Drawers: Sides dovetailed or doweled and securely glued into sub-fronts and drawer backs. Sides and sub-front plowed to receive bottom. Draw face to be back screwed to sub-front from interior of drawer.
- Complete fabrication, including assembly finishing, and hardware application, to maximum extent possible before shipment to Project site. Disassemble components only as necessary for shipment and installation. Where necessary for fitting at site, provide ample allowance for scribing, trimming, and fitting
- j. Notify Architect/Designer seven days in advance of the dates and times woodwork fabrication will be complete.
- k. Trial fit assemblies at fabrication shop that cannot be shipped completely assembled. Install dowels, screws, bolted connectors, and other fastening devices that can be removed after trial fitting. Verify that various parts fit as intended and check measurements of assemblies against field measurements indicated on Shop Drawings before disassembling for shipment.
- Shop-cut openings to maximum extent possible to receive hardware, appliances, plumbing fixtures, electrical work, grommets, and similar items. Locate openings accurately and use templates or roughing-in diagrams to produce accurately sized and shaped openings. Sand edges of cutouts to remove splinters and burrs.
- m. Measurements: Obtain field measurements and verify dimensions and shop drawing details as required for accurate fit. Provide ample borders to allow for subsequent scribing and trimming for accurate fit when construction schedule does not allow time for field measurements.
- n. Cabinet hardware shall be provided in completed casegoods items. Self-closing, self-dampening hinges to be provided on all casegood doors and drawers shall have full extension glides, unless noted otherwise.
- o. Preparations for finishing: Comply with referenced quality standard for sanding, filling countersunk fasteners, sealing of concealed surfaces and similar preparations for finishing of architectural woodwork, as applicable to each unit of work.

Transparent finish for open grain woods: Comply with requirements indicated below for grade, finish system, sheen.

Grade: Custom.

Finish: AWI Finish System conversion varnish for open grain wood

Color: Clear.

Sheen: as designated on drawings



All upholstered framed furnishing to have tight framed upholstery unless noted otherwise (see loose upholstery). All goods shall have nylon glides unless specified with leveling glides or other, as noted. Furnishings to comply with CAL 117, NFPA 260, CAL 133.

Submit shop drawings showing all fabricated upholstered goods in plan view, elevations, and cross-sections, to accurately indicate materials used, details of construction, dimensions, methods of fastening and erection, and installation methods proposed. Shop drawings to include seat pitch, back pitch, webbing or springs details and specifications, seaming diagrams, and joinery details. Shop drawings shall include a finish schedule of exposed finishes and upholstery. Goods to be factory finished, only final touch up, steaming, cleaning, and polishing, permitted after delivery and installation at the site.

- a. Tight seat upholstery: Fully upholstered seat and/or back, and arms (when applicable). Seat and back cushion to be fully crowned for a soft residential look and feel and not hard and flat looking. Crown of seat shall be about 4 inches higher than the outside perimeter. Constructed of medium density foam core with a high resilience foam 2535 Double Wrap. Core and wrap inserted into sewn casing of cotton muslin, before decorative finish fabric. Seat shall be constructed with non-sag spring construction in high grade steel.
- b. Frame Construction Frame shall be Kiln-dried hardwood, under controlled humidity and heat conditions to remove excess moisture and prevent future warping. Outside corners on the frame shall be beveled to prevent fabric wear. Frame joints jigsaw puzzle cut to reinforce the corners with blocking and double-dowel screws. Where feet are exposed, feet shall be finished in compliance with wood section above.
- c. Loose cushion upholstery: Cushions shall be contract quality, with concealed, nylon zipper at bottom of back cushions. Cushion to be removable from frame and shall be reversible.
 - a. Cushion (seat) Cushion to be fully crowned for a soft residential look and feel. Must not be hard or flat looking. Medium density foam core with a high resilience foam 2535 Double Wrap interior. Core and Wrap inserted into sewn casing of cotton muslin, before decorative finish fabric. Center of cushion should be about 4 inches higher than its outside perimeter. Concealed non-rusting zippers. Manufacturer to submit full size pillow samples to G70 for written



approval prior to fabrication. Loose cushions may be strapped or tied to frame, see specification for desired look and finish.

- b. Cushion (back) Cushion to be fully crowned for a soft residential look and feel. Must not be hard or flat looking. High resilience foam: 2535 Double Wrap, with concealed non-rusting zippers. Core and Wrap inserted into sewn casing of cotton muslin, before decorative finish fabric. All pillows to be fully reversible. Manufacturer to submit full size pillow samples to G70 for written approval prior to fabrication. Manufacturer to verify all cushion yardage requirements prior to production. Loose cushions may be strapped or tied to frame, see specification for desired look and finish.
- c. Frame Construction Frame shall be kiln-dried hardwood, under controlled humidity and heat conditions to remove excess moisture and prevent future warping. Frame joints jigsaw puzzle cut to reinforce the corners with blocking and double-dowel screws. Provide non-rusting, contract quality glides.

DECORATIVE HARDWARE- General:


a. All decorative hardware to comply to BHMA standards or equivalent ISO standards. Decorative Hardware shall be marine grade corrosion-resistant stainless-steel construction or solid cast bronze construction. Stainless Steel hardware shall comply with ASTM 240 or ASTM B-209. Solid bronze shall comply with ASTM B140. Solid bronze hardware shall be sand-cast or wax-cast, CNC or water-jet cut, and hand finished for a smooth patina and hand-rubbed polish.

METALS - General:

Brass: All brass furnishings and accessories to be fabricated of CU230 Alloy Red Brass (Gilding metal) consisting of 95% copper and 5% zinc, a soft brass alloy that can be easily hammered, cold formed, or forged into desired shapes. Sheet brass to be cut (hand cut, machine cut, CNC cut, or other) into desired shapes for cold forging and/or roll forming to achieve desired finished piece. Sheet brass to be stamped into a hammered patterning, refer to specification for desired pattern. No flux or solder to be visible. No sharp edges, all edges to be rolled or polished for a finished look and feel.


CORRIDOR RM 101 FFE SPECIFICATIONS




X-RAY RM 102 & X-RAY ALCOVE RM 102A
