A: Response from architect:

a. CG-01 – Marbled maple rejected. Please provide another selection. Physical samples required if awarded.

b. CG-03 – Arctic white and platinum metallic approved. Marbled maple rejected. Please provide another selection. Physical samples required if awarded. Missing hardware specs. Please provide.

- c. CH-01 Substitution approved. Need physical sample of seat upholstery if selected.
- d. CH-02 Substitution approved.
- e. T-01 Substitution approved.
- f. T-02 Substitution approved.

g. T-03 – If vendor is selected, will want to select finish closer to original spec with vendor to provide physical samples for selection. Need to reselect to a piece with the same height as original spec for T-03 in lactation rm 108. Height is too tall.

h. WS-01 – Top is approved. Leg finish approved. Vendor to confirm if there is architectural leg like original spec.

i. WS-02 – Top is approved. Leg finish is approved. Marbled maple rejected. Please provide another selection. Physical samples required if awarded. Vendor to confirm if there is another architectural leg like original spec. Missing hardware4 and tack board specs. Cannot tell from renderings if grommets and power match spec.

9. Q: Power is briefly mentioned in WS-02, but we wanted to confirm it is needed?

A: Yes, Power needed at Credenza as a power port at the top – provide 1 outlet and 2 USB ports.

10. Q: CG-03 mobile pedestal – are casters acceptable?

A: Yes mobile pedestal shall have casters.

11. Q: Task light is not specified in WS-02, is it needed?

A: Task light is not required and not noted in Spec.
